1. Privacy Policy for VATSIM BULGARIA

At BGvACC, accessible from <https://bgvacc.com>, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that are collected and recorded by BGvACC and how we use it.

This Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect in BGvACC. This policy is not applicable to any information collected offline or via channels other than this website.

2. Consent

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

3. Information We Collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear at the point we ask you to provide it.

If you contact us directly, we may receive additional information about you such as your name, email address, the contents of the message and/or attachments you may send us, and any other information you choose to provide.

When you register for an account or submit an application, we may ask for your VATSIM CID, name, and email address.

4. How We Use Your Information

We use the information we collect in various ways, including to:

- Operate and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Communicate with you directly
- Process your application
- Prevent fraud or abuse of the application system

5. Log Files

BGvACC follows a standard procedure of using log files. These files log visitors when they visit websites. The information collected includes IP addresses, browser type, ISP, date/time stamp, referring/exit pages, and number of clicks. This information is not linked to any personal data and is used for analyzing trends and improving the website.

6. Cookies

Like most websites, BGvACC uses cookies to store information such as visitor preferences and pages visited. This helps enhance the user experience by tailoring content based on browser type and other factors.

7. GDPR Data Protection Rights

If you are a resident of the European Economic Area (EEA), you have the following rights:

The right to access – You can request copies of your personal data.

The right to rectification – You can request correction of inaccurate or incomplete data.

The right to erasure – You can request deletion of your data under certain conditions.

The right to restrict processing – You can request limitation of data processing under certain conditions.

The right to object – You can object to data processing under certain conditions.

The right to data portability – You can request transfer of your data to another organization.

If you make a request, we have one month to respond. Please contact us to exercise any of these rights.

8. Children's Information

We do not knowingly collect any personally identifiable information from children under the age of 13. If you believe your child has provided such information on our website, please contact us and we will promptly remove it.
